#### Explanation:

How does one judge the quality of scholarship and pedagogy? One standard, objective, quantitative measure of scholarly influence traces the dissemination of a scholar's work through its citation by others. This method, described and popularized by researchers such as Diana Crane, determines a scholar's impact by gauging how widely the scholar's work is recognized in scholarly and pedagogical communities.
